
## Tuning Academy: RUG

Tuning Academy is an **International Higher Education and Research Centre** for the development and enhancement of the quality of learning, teaching and assessment in higher education.

It has its origin in successful innovation which has been carried out in close cooperation with the **University of Deusto (Spain)** and the **University of Groningen (The Netherlands)** since 2000.

Focuses on 2 pillars:

1. Design of compatible and comparable degree programmes
2. Contribution to a full implementation process supporting capacity building



### Past Achievement in ASEAN

- **Tuning Asia- South East (TASE)**: implementing Bologna Tools in South East Asia universities through building a framework of comparable and compatible qualifications.

## WHAT IS CALOHEA?

The CALOHEA project unites thirty-one institutions across eight countries within ASEAN and five countries within Europe. The institutions create teams in the subject area of Civil Engineering, Medicine and Teacher Education. Together these teams form a Subject Area Group (SAG).

The **ASEAN University Network (AUN)** acts as a coordinator within the region, while the **University of Groningen (RUG)** is the project coordinator.

Participating institutions were carefully selected over shared values and complementary expertise for maximum impact at institutional, national and regional levels.

This large-scale project addresses the issues faced by institutions in the South-East Asia (SEA) Region. It specifically focuses on internationalization and the **3 Key Recognition Mechanisms (RMs)**.

## What is National Meeting?

CALOHEA National Meeting is a major part of CALOHEA dissemination activities, where CALOHEA Recognition Mechanisms will be showcased to relevant stakeholders, in order to promote the use of Recognition Mechanisms and seek implementation plans for each nation within the project.

**The National Meetings** are designed with the vision to bridge the knowledge gap between the Project Consortium and other relevant stakeholders in ASEAN Higher Education to seek mass adoption of the mechanisms in the ASEAN region.

In order to ensure the maximum impact, and the widest possible outreach in every National Meeting, the events focus on the representativeness and the involvement of national beneficiaries from in- and outside of the project.

### Description

4. **September 2023**, The Philippines, hosted by Ateneo de Manila University (ADMU)

## Background of the project

The CALOHEA project's ultimate aim is to **increase and enhance the internationalisation effort of ASEAN Higher Education Institutions through degree recognition**. In order to realise its goal, the project focused on establishing and systemise the implementation of three Recognition Mechanisms of study programmes:

1. Regional Subject-specific Qualifications and Assessment Reference Framework
2. Student Workload Calculation
3. Authentic Assessment of Learning Outcomes

As such, in order to fully optimise the systematic use of Recognition Mechanisms, the project requires mass adoption of the mechanisms in the ASEAN region not only from inside but also outside of the Project Consortium.

## Background of the National Meeting

**CALOHEA National Meetings** are designed from this vision to connect the knowledge between the Project Consortium and other relevant stakeholders in ASEAN Higher Education in an effort to seek mass adoption of the mechanisms in the ASEAN region. Moreover, In order to ensure the maximum impact of each National Meeting, as well as the quality, and the widest possible outreach in every National Meeting, the events are co-organised between the AUN Secretariat, the Dissemination Board, and the local universities, focusing on the representativeness and the involvement from national beneficiaries from in- and outside of the project.

During the project, two National Meetings will be organised in at least two significant strategic locations of each of the seven ASEAN countries (Cambodia, Indonesia, Laos, Malaysia, The Philippines, Thailand, and Vietnam). **The main goal of the National Meeting is to present every CALOHEA product to the public and exemplify how each stakeholder can benefit from exploiting CALOHEA outputs** that will ultimately result in the recognition study programme that contributes to the enhancement of internationalisation in ASEAN Higher Education.

The meeting is targeting representatives of all ASEAN HEIs, and key ASEAN Higher Education actors (host institution(s) staff & students and – mainly – staff and students of other ASEAN HEIs (who are not members of the CALOHEA consortium), as well as employers, representatives of professional organisations, quality assurance agencies, accreditation agencies, Ministries of Education and other policymakers, graduates, prospective students and members of the society at large.

## Main objectives

- As part of CALOHEA's goals to enhance and increase mobility within the region and facilitate interregional mobility that will altogether contribute to the internationalisation effort of ASEAN HEIs, the National Meeting's objectives are:
  - To promote participants' awareness and understanding of the benefits and how to effectively utilise CALOHEA Recognition Mechanisms to increase and enhance mobility in higher education.
  - To be a platform to promote internationalisation in higher education among the partners in the ASEAN and EU region.

## Specific Objectives

### ASEAN region

- To present the opportunity for advancing internationalisation across Southeast Asian Higher Education Institutions (HEIs) by introducing Recognition Mechanisms.
- To provide a foundation for strategizing and formulating a policy in regard to the enhancement of internationalisation in the Southeast Asian region.
- To promote a strong network of ASEAN Internationalisation and Recognition Champions, who can foster a cross-national approach to internationalisation in order to improve inter-regional and global relevance and partnerships.

### ASEAN Higher Education Institutions

- To encourage the implementation of Recognition Mechanisms among ASEAN HEIs.
- To create a mutual understanding among ASEAN HEIs on the practical benefits of implementing Recognition Mechanisms that can contribute to each institution's internationalisation efforts.
- To provide the tools and training that support the capacity building of staff in the field of Quality Assurance, as well as institution and study programme design.
- To address and ease any limitation that arises from implementing Recognition Mechanisms in the practical field.

### Students

- To present the opportunity for improving student mobility that comes with the recognition of more study programmes.
- To present more accountability in student workload and its direct benefit to students.
- To present the changes in the new way of authentic assessment that will help the student achieve their desired learning outcomes.
